# Executive Summary

*Yings Sushi Bar, 59 Center St, Hyannis, MA 02601*

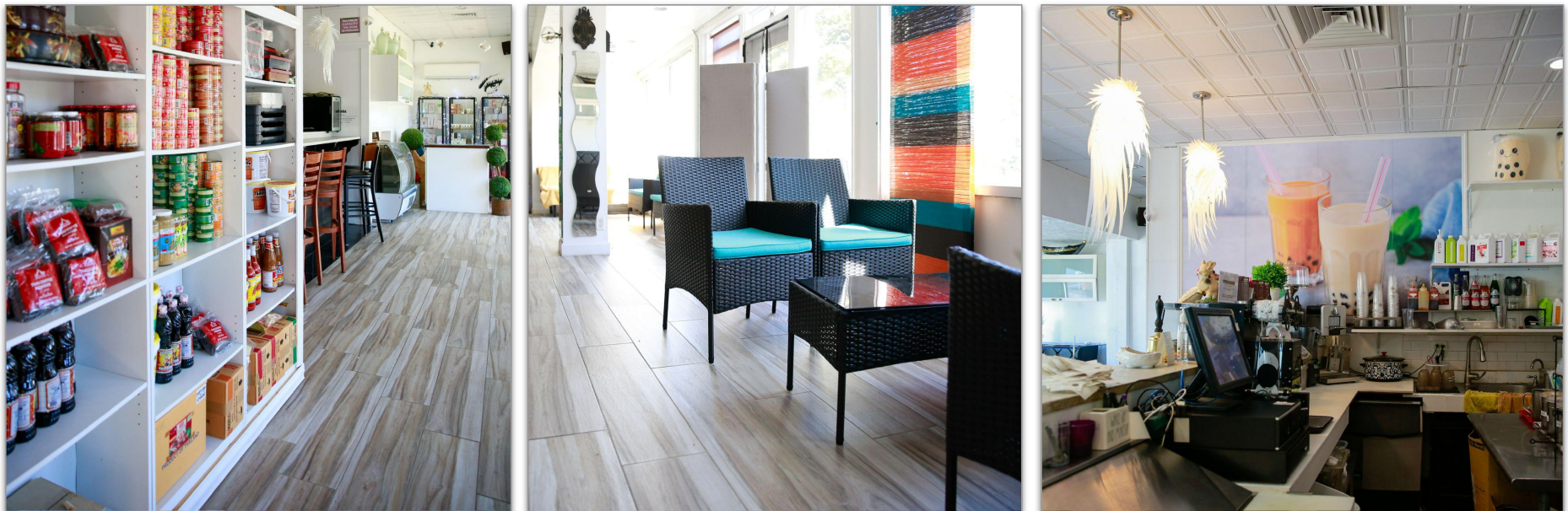
Yings Sushi Bar & Lounge, located in downtown Hyannis, is one of Cape Cod's premier Asian fusion restaurants and nightlife destinations. Founded in 1999, the business has thrived under the same ownership for twenty-six years, evolving from a small shop focused on Thai and sushi dishes into a full-service dining and entertainment venue. Today, Yings offers a diverse menu featuring Japanese, Thai, and Korean cuisine, a full sushi bar, specialty cocktails, and its popular scorpion bowls. The restaurant also features an expansive dining area, four-liquor bar, outdoor seating, and a modern lounge atmosphere.

Over the years, Yings has built a strong and loyal customer base comprised of both locals and seasonal visitors. The local clientele reflects Hyannis's diverse year-round population, including American, Brazilian, Hispanic, Eastern European, and Jamaican patrons. Customers range in age, but the majority fall between 20 and 55 years old—an active and social demographic that values both quality dining and lively nightlife.

The restaurant has undergone multiple remodels and expansions, transforming from a casual eatery into a middle-to-high-end dining and lounge experience. In 2010, a liquor bar and entertainment license were added, introducing live events that successfully boosted revenue for nearly a decade until paused during COVID. In 2019, the addition of Keno further enhanced the customer experience, blending dining, drinks, and entertainment under one roof.

There are significant opportunities for growth under new ownership. Reintroducing live entertainment by reinstating an entertainment license could provide an immediate boost to revenues. Expanding catering operations, enhancing marketing efforts, and strengthening the restaurant's digital presence would further drive sales. Partnerships with delivery services, refined menu development, and operational optimization present additional avenues for increased profitability.

After more than two decades of success, the current owner is preparing to retire, creating a unique opportunity for a qualified buyer to acquire this established, turnkey operation. With its prime downtown Hyannis location, diverse and loyal customer base, and long-standing reputation for quality and atmosphere, Yings Sushi Bar & Lounge stands out as one of Cape Cod's most appealing restaurant and nightlife acquisition opportunities.
